Vouchers must be presented <u>in person</u> and Proof of ID will be requested on purchase of school clothing. Acceptable Proof of ID is a Driving Licence, Bank statement or Utility bill, ie Council Tax bill.

If your application is incomplete or unsuccessful, the Trust will contact you directly using the information you have provided on your application form.
